Pre-Service Program Requirements

- Attend an Informational Meeting to learn about the program and determine eligibility
- Hold a Bachelor degree ([official transcripts are required](#))
- Successfully pass a Basic Skills Requirement Test - for most, this will be the California Basic Educational Skills Test (CBEST)*
- Complete Subject Matter Competence - for most, this will be the California Subject Matter Examination for Teachers (CSET)*
- Provide receipt of your [Certificate of Clearance from CTC](#)

Intern Program Requirements

All of the above plus...

- Attend an Advisement Meeting to learn about the program and determine eligibility
- Successfully complete pre-service course work
- Complete the [U.S. Constitution Requirement](#) (exam or class)
- Valid TB test
- CPR certification
- Provide verification of an offer of employment as “Teacher of Record” from a participating district. (Employment must be at least .5 Full-Time Equivalent in the established credential area)

Applications accepted November 10, 2020-January 8, 2021

*As per Executive Order N-66-20, flexibilities have been extended on the entrance requirements for pre-service and/or intern programs regarding the passage of the CBEST and CSETs. CBEST and CSETs are not a requirement for entrance into the pre-Service or intern programs until August 2021. CBEST and CSET exams must be passed prior to completing an intern program.
